

Ethical Considerations and Responsible Artificial Intelligence in Data Practice: A Framework for Trust and Accountability

ABSTRACT: The growing use of Artificial Intelligence across industries is transforming how organizations operate while raising important ethical concerns. This paper explores key issues such as bias, fairness, transparency, and privacy, emphasizing the need for responsible frameworks that connect technology with human values. Drawing from global and Nigerian contexts, including UNESCO's AI ethics principles and Nigeria's Data Protection Act, the study reviews existing frameworks and analyzes professional experiences to identify best practices in ethical AI adoption. It discusses strategies such as human-centered design, regular auditing, and cross-sector collaboration to support fairness and accountability. The findings indicate that leadership commitment, respect for privacy, and robust governance are crucial for fostering public trust in AI. The paper concludes that responsible and ethical use of AI is not only necessary for fairness and equity but also for ensuring the long-term success and acceptance of AI systems. It also provided recommendations for further research.

I. INTRODUCTION




Figure 1: Categories of Bias

Artificial intelligence has become deeply integrated into almost every aspect of daily life, transforming industries such as finance, education, and healthcare through data-driven decision-making, among others. While these advancements offer significant benefits, they also pose potential risks that need careful management. Over the past year, emphasis has increased on ethically developing and responsibly deploying AI systems to tackle these challenges effectively. AI continues to revolutionize industries at an unprecedented pace, sparking important ethical debates about its use, ownership, accountability, and long-term impacts on humanity (Accenture Risk Study, 2024). Current data for 2025 suggests that up to 90% of commercial applications will incorporate AI in some form this year (Maslej et al., 2025). However, despite rapid adoption, many leaders still feel unprepared to handle potential risks. Recent reports show that over 80% of organizations lack readiness for AI regulatory compliance, and only 6.4% have advanced AI security plans. New research from the University of Washington has revealed significant racial, gender, and intersectional biases in AI systems used for automated resume screening and candidate ranking (University of Washington, 2024). The study evaluated three large language models (LLMs) developed by Mistral AI, Salesforce, and Contextual AI. A total of 550 real-world resumes were tested, each paired with 120 distinct names representing White and Black men and women to examine the influence of perceived identity on ranking outcomes (Capitol Technology University, 2024). In the study of Shanklin et al. (2022), it was revealed that algorithms predict that black patients are more likely to miss appointments than non-black patients in terms of medical appointment scheduling in the United States. This could be technically accurate based on the data available, but black patients will have longer wait times in being scheduled for an appointment, leading to racial inequalities and creating a lack of access to healthcare. Research

reveals that biases still exist in the use of AI in data practice (Buolamwini & Gebru, 2018; Suresh & Guttag, 2021). These biases are discussed and shown in Figure 1.

Gender bias involves prejudiced or unequal outcomes based on an individual's gender in automated decision-making systems. This form of bias often arises from the use of non-representative datasets, societal stereotypes, or structural inequalities embedded in algorithms, leading to disparities in areas such as hiring, healthcare, and education (Ntoutsi et al., 2020). Eliminating gender bias necessitates incorporating representative data and regularly auditing algorithms for discriminatory patterns (Hanna et al., 2025). Racial bias refers to algorithms and datasets that produce unfair or discriminatory outputs due to historical inequalities or the underrepresentation of certain racial groups. This bias tends to perpetuate existing societal prejudices, affecting critical domains such as criminal justice, banking, and access to public services (Belenguer, 2022). Addressing racial bias requires dedicated efforts in diverse data collection, transparency in model development, and ongoing bias mitigation strategies (Schwartz et al., 2022). Intersectional bias, on the other hand, describes the compounded disadvantages experienced by individuals belonging to multiple marginalized groups, such as race and gender combined. Unlike isolated biases, intersectional bias recognizes that overlapping identities can result in unique forms of discrimination not accounted for by examining each dimension separately (IBM, 2023). Research highlights those intersectional approaches are necessary for understanding the full spectrum of algorithmic bias and its social effects (Oxford Law Pro, 2025). Intragroup disparities concern variations in outcomes among individuals within the same social group. These emerge when models yield uneven treatment in subgroups, such as differences in opportunities among women of varying ages, or among individuals of the same ethnic background but different socioeconomic status (Ntoutsi et al., 2020). Academic findings suggest that fine-grained analysis and subgroup fairness audits are essential for detecting and managing these disparities in AI applications (Soleimani et al., 2025). Data practice refers to the methods, processes, and behaviors involved in collecting, managing, analyzing, sharing, and using data within an organization or research setting. The capacity of AI to amplify inequalities is evident not only in areas like medical appointment scheduling and employment but also in broader sectors, including education, judicial systems, and public safety. Figure 1 shows the various categories of bias evident in AI algorithms.

Dordunoo (2025) pointed out that biases from unrepresentative datasets can lead to discriminatory outcomes. A review of AI ethics frameworks indicates that bodies such as UNESCO, China, the European Union, and prominent technology organizations prioritize the reduction of bias within AI decision processes, the promotion of transparency, and the prevention of discriminatory algorithmic outcomes. Nevertheless, the absence of a standardized global framework sparks the urgent need for enhanced international collaboration to regulate ethical data practices in AI (Slimi & Carballido, 2023). Kottur (2024) introduced a multi-stakeholder model for implementing responsible AI practices, laying emphasis on the importance of cross-disciplinary collaboration, continuous education, and robust oversight mechanisms. There remains a significant gap in the availability of comprehensive ethical frameworks to guide socially responsible AI development. They emphasize that embedding principles of fairness and accountability within AI systems is imperative for building trust and promoting responsible use. Furthermore, the study calls for intensified research into regulatory mechanisms, highlighting existing deficiencies in current regulatory strategies. Table 1 reveals the various aspects of data practice from data collection to Data ethics. It is abbreviated as CMASE.




Figure 2: Diagrammatic Description of the Aspects of Data Practice




Figure 3: AI adoption, Regulatory Preparedness and Advanced AI Security Statistics for 2025

The findings indicate that AI-driven recruitment systems, though intended to enhance hiring efficiency, may inadvertently reproduce and intensify existing social inequities. Such biases continue largely because these systems are not transparent, and there are few regulations to hold developers accountable. Figure 3 illustrates the current state of AI adoption in organizations as at 2025. Over 80% of organizations report being unprepared to manage AI-related risks, underscoring the need for stronger governance structures and responsible innovation frameworks (OpenAI Governance Research Group, 2024).




Figure 4: Non-linear Projection of AI Adoption, Regulatory Preparedness and Advanced ai Security Statistics (2025 - 2030)

Figure 4 illustrates the evolving landscape of AI adoption, regulatory preparedness, and security strategies, emphasizing important ethical considerations from 2025 to 2030. AI Adoption starts high at 90% in 2025 and is projected to reach 98% by 2030, indicating near-universal integration of AI across organizations. Preparedness begins low at 20% in 2025 but is expected to rise to 80% by 2030. This gap shows a vulnerable phase where AI use outpaces governance frameworks. Strengthening regulations and governance during this period is essential to enforce ethical AI principles and protect individuals and society from potential harms (OECD, 2025; McKinsey, 2025). AI Security Strategy for the year 2025 starts at 6.4% and may rise steadily to 70% by 2035, reflecting growing awareness and maturity. Despite the AI adoption is widespread, the Regulatory Preparedness and AI Security Strategy has not been fully implemented, which calls for continued actions in developing responsible AI and data practices. AI's rapid integration into business intelligence and data analytics is reshaping decision-making, improving efficiency, and extending services to new populations. However, these advancements also raise urgent ethical issues such as bias, transparency, explainability, privacy, and accountability. Addressing these is essential, not only for compliance but for sustaining public trust and maximizing societal benefit.

Ethical Considerations in AI and Data Practice

Data professionals face a series of ethical challenges, such as:

- (a). **Fairness and Bias Mitigation:** AI systems often reproduce or intensify the biases embedded in their training data, as illustrated in **Figure 1**. To address data practices where AI may aggravate inequalities, key strategies include conducting bias audits, using diverse representative datasets, employing fairness-aware algorithms, engaging diverse stakeholders in governance, and maintaining continuous monitoring of AI outcomes. Continuous evaluation and transparency of algorithms are vital to prevent discriminatory outcomes, especially in multicultural societies (Duong & Conrad, 2024). It is imperative to commit to impartial treatment and remove biases in data and algorithms by ensuring inclusiveness and representativeness at every stage of AI development.
- (b). **Transparency and Explainability:** Stakeholders demand clear, understandable explanations for AI-driven decisions. Transparent development processes and open communication foster trust and comprehension among users and regulators as stated by Pillai, (2024). It is therefore expedient to maintain openness in modeling, data sources, and system logic to provide meaningful explanations. AI systems should be developed to ensure clarity and explainability, enabling users to easily understand the rationale behind decision-making processes.
- (c). **Privacy and Data Protection:** Responsible management of data is fundamental to this framework, requiring strict adherence to privacy laws and secure handling of sensitive information. It involves maintaining the integrity of data by ensuring its accuracy, completeness, and consistency throughout its lifecycle. Ethical data practices also incorporate securing informed consent from data subjects, safeguarding against unauthorized use, and ensuring that datasets are representative to avoid bias during AI training and validation. The collection and processing of personal data by AI systems necessitate robust privacy protections, including data minimization, consent protocols, and rigorous audits (Zoho, 2025).
- (d). **Balancing Automation with Human Control:** Artificial intelligence systems should be designed to respect and support human agency, ensuring that they complement rather than replace or unduly influence critical human decisions, especially in sensitive domains such as healthcare, law enforcement, employment, and finance, among others.
- (e). **Security and Robustness:** AI systems must be resilient to cyber threats, adversarial attacks, and operational failures. Regular testing and updating are needed to ensure safe and reliable performance. Robustness is ensured by developing AI systems that perform reliably under various conditions, including unexpected scenarios. The framework emphasizes rigorous testing, validation, and ongoing monitoring to maintain system integrity, prevent failures, and uphold consistent ethical standards in real-world applications.
- (f). **Accountability and Governance:** Clear delineation of responsibility for AI outcomes is essential. Clear accountability structures should be established within organizations to oversee adherence to ethical standards. This includes defining roles and responsibilities for AI oversight, maintaining comprehensive documentation,

and instituting review mechanisms to hold developers and deployers responsible for AI impacts. Responsible AI stresses the ethical and legal use of an Artificial Intelligence-based system, including its auditability, accountability, and liability (Herrera-Poyatos et al., 2025). Ain (2024) presented an ethical framework for AI decision-making that integrates key ideas from utilitarianism, deontology, and virtue ethics. The framework aims to promote transparency, fairness, and accountability, while addressing bias in AI applications across different sectors. According to Sridhar (2025), a systematic review was conducted on ethical AI frameworks and identified a scarcity of case studies, along with a lack of concrete metrics to evaluate trustworthiness and the results of AI deployment. Dordunoo (2025) highlighted the importance of integrating fairness and accountability into AI systems to build trust and promote responsible usage. It calls for robust ethical frameworks and transparent practices aimed at mitigating biases, supporting ethical AI development, and strengthening accountability in data management.

II. METHODOLOGY

This study, which is qualitative research, adopted a comprehensive literature analysis, selecting peer-reviewed articles, public reports, and ethical frameworks published between 2019 and 2025. Sources were identified using targeted searches in databases such as Google Scholar, Scopus, and Web of Science, and also organizations' official sites, which include the Organization for Economic Co-operation and Development (OECD), the Nigerian Data Protection Acts, and the United Nations Educational, Scientific and Cultural Organization (UNESCO). Key terms searched include 'bias', 'fairness', 'transparency', 'privacy', 'data governance', 'ethical consideration', 'responsible AI', 'data practice', 'ethical AI', 'policy integration', and 'accountability' relating to AI-driven data practices relevant to both global and Nigerian contexts. Articles not written in English and inaccessible documents were excluded. Issues not related to ethical AI were also excluded as shown in Table 2.

A. Analysis Structure

Selected papers were analyzed using thematic analysis to identify prevailing principles, challenges, and implementation strategies, supplemented by comparative analysis between global and Nigerian ethical AI adoption models. Texts were reviewed for recurring themes such as fairness, accountability, transparency, human well-being, and social impact. Sectors such as healthcare, finance, education, and employment were given specific attention with the ethical challenges they face, which include bias, privacy concerns, security, accountability, and governance, among others. This approach provides responsible AI frameworks that align technology with human values. Drawing from global and Nigerian contexts, the paper highlights frameworks like UNESCO's AI ethics principles and Nigeria's Data Protection Act. It proposes actionable strategies that are foundational to AI's social acceptance and long-term success. By aligning insights from academic and policy domains, the review supports ethical considerations and Responsible AI in various aspects of data practice.

B. Frameworks and Principles for Responsible AI

Recent research identifies a “Nigerian Model” that places privacy and executive leadership at the core of responsible AI adoption:

- (a). Leadership Commitment: Executive roles drive AI integration, moving companies from experimentation to operational scale with a commitment to privacy and ethical governance (Papagiannidis, 2025).
- (b). Privacy-First Approaches: More than 84% of Nigerian companies have enhanced their data privacy measures following AI deployment, frequently surpassing global standards. This trend is evidenced by the appointment of dedicated privacy officers and the allocation of increased IT budgets for privacy management, reflecting a clear prioritization of privacy protection within AI frameworks (Adediran et al., 2024; Adeyefa et al., 2024).
- (c). Skills Development and Human Capability: Nigerian organizations emphasize training in data analysis, AI literacy, and prompt engineering, recognizing human skills as more critical than mere technology acquisition.
- (d). Proactive Regulatory Compliance: The Data Protection Act of Nigeria has recorded a shift from regulatory preparedness and has increased regulatory consciousness, leading to regular audits and explainability requirements aligning with international best practices (Ozibo, 2025; National AI Strategy, 2025).

Global Ethical Frameworks

The *UNESCO (2021) Recommendation on the Ethics of Artificial Intelligence* outlines several guiding principles that form the moral and operational foundation for responsible AI governance such as:

- (a). Guiding Principles: Proportionality (“Do No Harm”), safety and security, right to privacy, multi-stakeholder governance, autonomy, justice, and explicability (UNESCO, 2021).
- (b). Policy and Compliance: Adoption of ethical AI frameworks at organizational and governmental levels should complement existing data protection and cybersecurity standards.

While global ethical frameworks such as UNESCO’s Recommendation emphasize universal principles like justice, autonomy, and explicability, the Nigerian approach uniquely tables privacy and leadership-driven governance. Nigerian organizations demonstrate stronger enforcement of privacy through the Data Protection Act and prioritize skills development in AI literacy and prompt engineering. However, both contexts face persistent challenges including biases embedded in datasets, gaps in regulatory enforcement, and a shortage of standardized metrics for evaluating ethical AI performance. Real-world implementation hurdles, such as balancing rapid AI adoption with evolving regulations and workforce readiness, remain significant barriers that require adaptive governance and collaboration across sectors to overcome.

C. Implementation: From Principles to Practice




Fig. 5: Architectural Workflow

Implementation of responsible Artificial Intelligence (AI) requires a holistic and sustained approach that embeds ethical, social, and technical considerations throughout the AI system's lifecycle. This path involves several interrelated components:

Human-Centered Design: Responsible AI development begins with the active involvement of users, domain experts, and affected communities across all phases from planning and data collection to model deployment and evaluation. This participatory approach ensures that AI systems genuinely address human needs, reflect societal values, and minimize the risk of unintended harm.

Continuous Monitoring and Audit: Responsible AI is not a one-time achievement but an ongoing commitment. Continuous monitoring and auditing of system outcomes are essential to assess fairness, transparency, accuracy, and compliance with evolving standards. Regular updates and independent audits help identify emerging risks and align system behavior with shifting societal expectations.

Policy and Governance Integration: Embedding ethical AI principles into organizational policies and governance structures ensures accountability and consistency. This includes integrating ethical review processes, using industry-standard toolkits, and adopting formal assessment templates across every stage of project delivery. Such institutionalization promotes transparency, mitigates ethical risks, and fosters public trust in AI technologies.

D. Challenges in Achieving Responsible AI

Despite progress, data professionals face persistent obstacles:

The transition from ethical AI principles to practical implementation faces major challenges, including limited technical expertise, data scarcity or bias, and regulatory gaps. These issues weaken fairness tool adoption, distort AI outcomes, and reduce accountability, necessitating targeted training, diverse data initiatives, and stronger enforcement of Nigeria's Data Protection Act and related sectoral policies.

- (a). Lack of technical expertise: A shortage of skilled professionals and technical expertise is reported by 68% of IT leaders as a major obstacle to technology implementation (Digitalization World, 2024). Additionally, there is a critical gap in technical talent within governance institutions, underscoring the need for stronger research capacity and specialized workforce development to ensure effective oversight and management (OpenAI Governance Research Group, 2024).
- (b). Data scarcity or bias: According to Adam & Boateng (2021), the lack of diverse and representative training data is highlighted as a major source of bias in AI. In African contexts, it has been noted that the availability of well-curated datasets remains severely limited, hindering the training and validation of AI models (Muriuki & Wambugu, 2025).
- (c). Privacy and Security Risks: The open sharing of data and advanced analytics complicate the task of safeguarding sensitive information.
- (d). Regulatory gaps: Scholars observed gaps between regulatory ambitions and technical capacity. In many Artificial Intelligence systems, biases in the data and algorithm yield discriminatory and unethical outcomes, linked to weak governance. Eke & Nwafor (2024). As countries continue to evolve their AI governance structures, organizations must stay alert and flexible to meet new regulatory expectations and ethical requirements (Rahwan et al., 2021).

This study is primarily conceptual and qualitative, drawing from secondary data and comparative analysis of global and Nigerian frameworks. While it provides theoretical and policy insights, it does not empirically test the proposed framework. Future research should explore quantitative validation of ethical AI implementation indicators, particularly in developing contexts where governance capacity and digital literacy differ significantly. Moreover, longitudinal studies could assess how the integration of ethical principles evolves with technological advancement and regulatory adaptation. Expanding this analysis to include private-sector practices and cross-regional comparisons in Africa would further strengthen the generalizability and practical relevance of responsible AI governance models.

III. Conclusion

Integrating ethical considerations throughout AI development is essential for sustained societal trust and equitable innovation. Policymakers and organizational leaders should adopt measurable frameworks that monitor fairness, explainability, and privacy compliance, supported by enforceable regulations such as Nigeria's Data Protection Act. Clear accountability pathways and governance structures must be mandated, alongside investment in workforce capacity building. Cross-sector collaboration between government, industry, and academia is crucial to align local practices with global standards, creating an adaptive policy environment that promotes transparent, fair, and responsible AI deployment.

- (a). Data professionals must champion ethical discussions, continuously educate themselves, and implement robust governance processes.
- (b). Organizations should form cross-functional teams responsible for monitoring AI ethics, privacy compliance, and transparency. These teams will facilitate the embedding of ethical principles into operational AI workflows and report on key performance indicators (KPIs) related to fairness and privacy adherence.
- (c). Invest in Workforce Capacity Building
 - a. Governments and organizations should invest in training programs and professional development to equip the AI workforce with the needed ethical knowledge and technical skills, to ensure effective policy implementation and innovation management.
- (d). Encourage cross-sector collaboration

- a. Regulators, industry leaders, and academic institutions need to collaborate on dynamic standards and best practices that can adapt to AI innovations. This includes aligning national policies with international ethical guidelines and standards to maintain global competitiveness and social responsibility.
- (e) Regulators, industry leaders, and academia need to collaborate on adaptive design standards that can keep pace with innovation.






