Review articles and editorials without empirical evidence or methodological contributions were excluded from consideration.

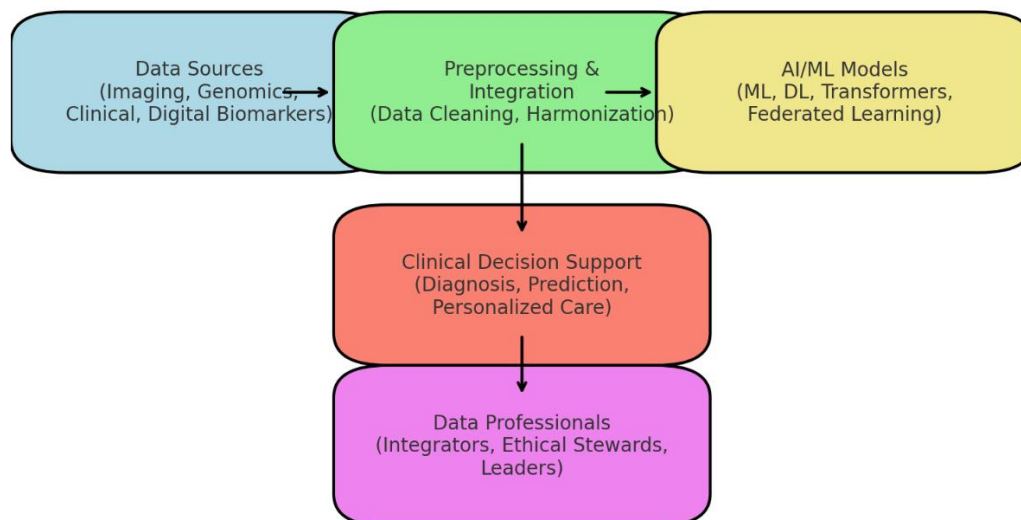
### A. AI in Healthcare and Multimodal Data Integration

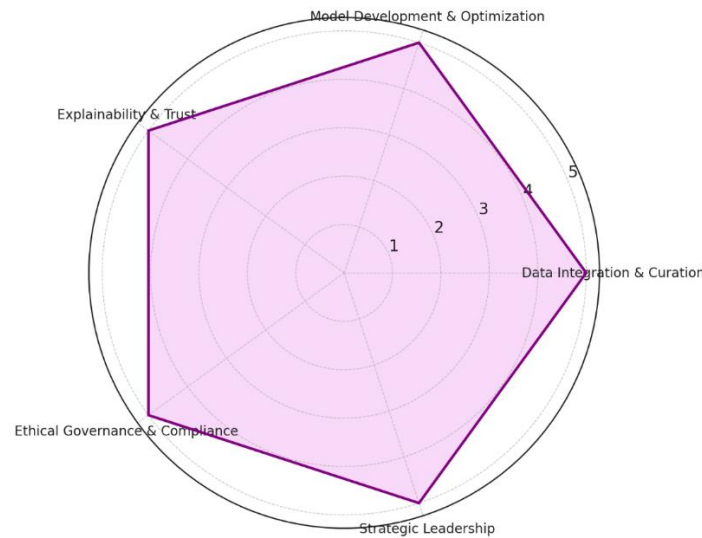


Figure 2. Roles of data professionals in multimodal healthcare AI.

#### (d). Real-Time Monitoring via Wearables and IoT

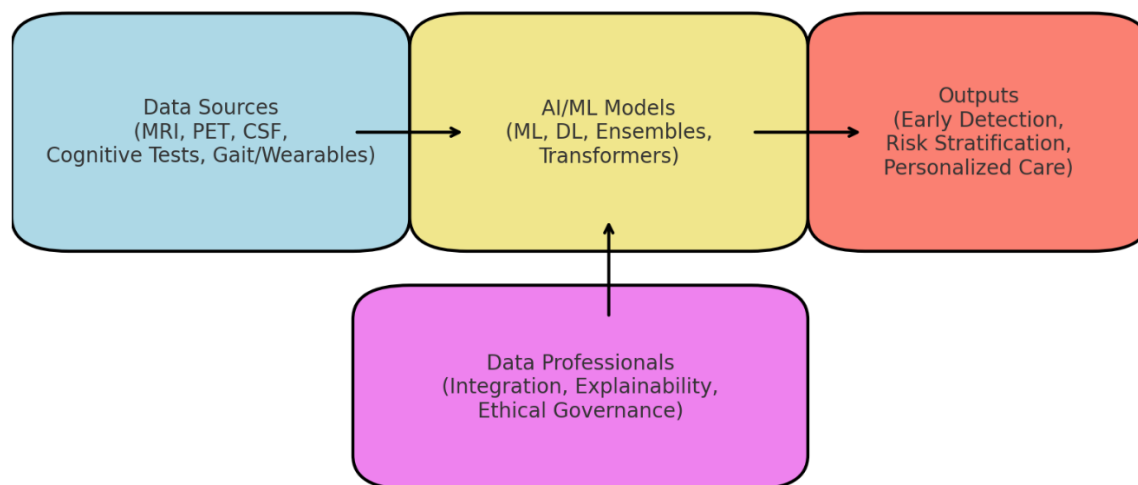

#### **(e). Interdisciplinary and Collaborative Models Clinician–Data Scientist Partnerships**

The successful implementation of multimodal healthcare AI depends on close collaboration between clinicians and data professionals. Clinicians contribute essential domain knowledge, understanding disease mechanisms, diagnostic criteria, and patient care needs, while data professionals offer technical expertise in data integration, algorithm design, and model optimization. This interdisciplinary partnership ensures that AI systems are clinically relevant, transparent, and seamlessly integrated into existing workflows. Collaborative design and evaluation processes, such as co-development and iterative testing, enable the development of tools that are both scientifically sound and practically useful. By fostering mutual understanding

between technical and clinical teams, healthcare organizations can enhance trust, improve adoption, and ultimately ensure that AI innovations translate into better patient outcomes [5].

### **International Data Sharing Initiatives**

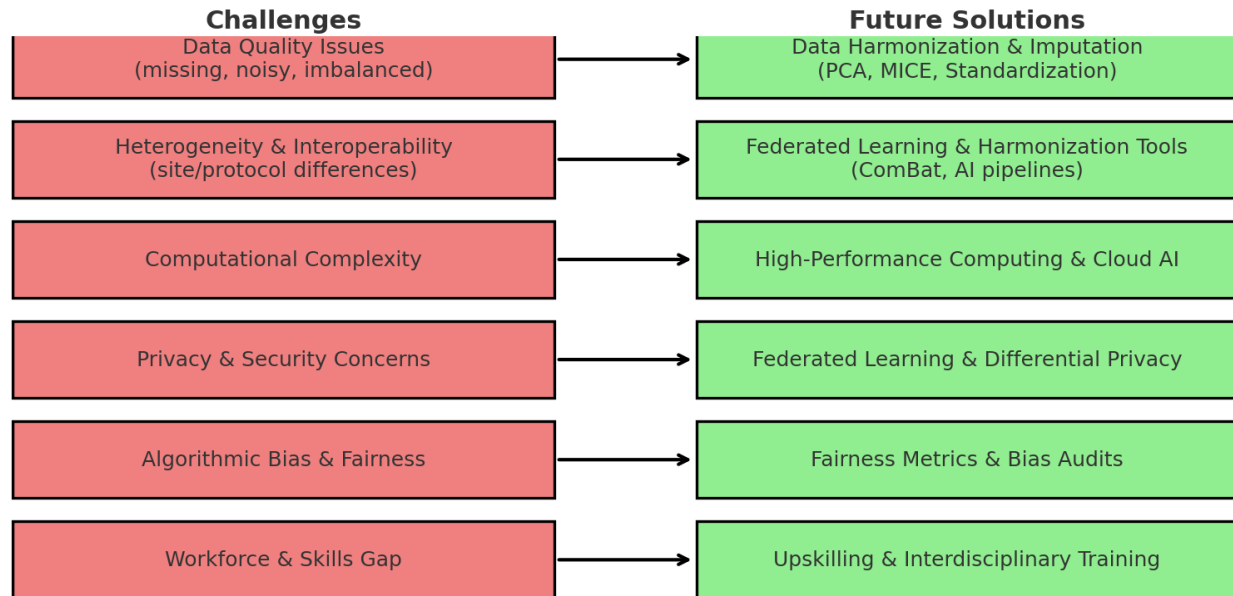
### **Ensuring Fairness and Equity**

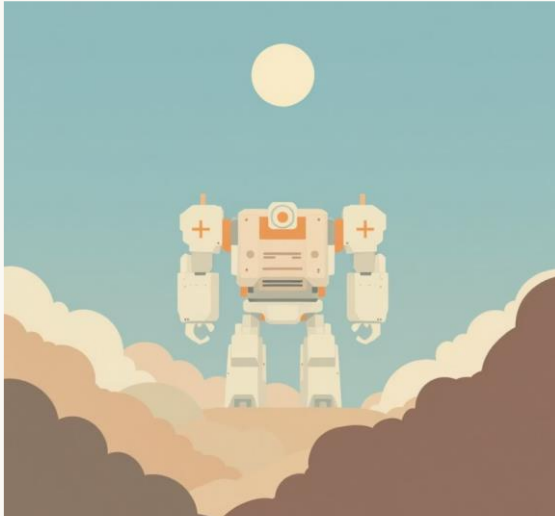

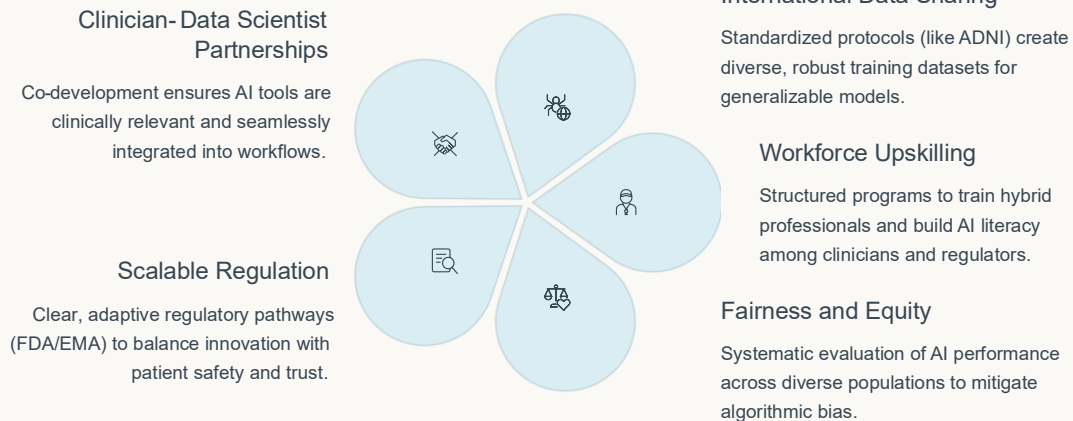
